

# Letter from the Chairman, no 11 Stockholm June 16th 2015

Dear members and friends of the World Taxpayers Associations!

Here a start with some quotes from Alan Greenspan, at 89 still one of the worlds most influential people:

"Negative interest rates are against human nature."

"We are on the right track but going very slowly. We have lots to catch up on, but have stopped adding new insecurities"

"The American spirit is on the way to becoming like the European. We are not quite like Greece yet, but working on it. We have a lack of investments, which have dropped vs GNP, and are not growing. And we have the demographic factor with those born in the US between 1946 and 64 approaching pension age"

"We are loosing control of our budget deficit, which has grown out of additional entitlements, growing at 9 or 10 % per year. This is a political factor, not a market factor, and it will eventually push out savings, which are the basis for investments and increased productivity."

He also says that "the sooner Greece leaves the Euro the better for all. They should never have had the Euro. Today most of the debt is owned by other states and institutions, so the risk of spreading is small, even if of course there will problems. We tried to join very different economic cultures (in creating the Euro), and today there is no mechanism to get out of it."

A quick lesson in economics from a major interview in the Swedish business daily Dagens Industri June 13, 2015.
